### A Message to Our Members



At Kimberly Clark Credit Union, the security of your financial information is our top priority. We urge all our members to exercise caution with their account and personal details. Please remember, never share sensitive information like your account number, username, password, or verification codes with anyone. Equally, your social security number is confidential. KCCU will never contact you to request this information. If you receive such a request, it's imperative to immediately hang up and contact KCCU directly. Your prompt action is crucial in preventing potential fraud.

Additionally, we'd like to offer a friendly reminder regarding transaction names in your account history. Sometimes, the name that appears might be that of the parent company, not the specific store where you shopped. Before reporting a transaction as fraudulent, please take a moment to double-check, especially if your account is shared or if a family member has access to your debit card. This extra step helps avoid confusion and ensures that the transaction in question isn't actually a legitimate one. We appreciate your attentiveness in these matters, as it significantly aids in maintaining the security and accuracy of your account.
