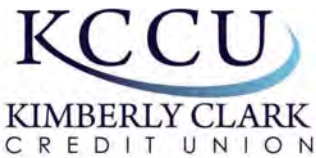

Kimberly Clark Credit Union is seeking applicants for \$20,000 in college scholarships

Kimberly Clark Credit Union is currently accepting applications for our 2023 scholarship program.

We plan to award a \$1,000 scholarship to twenty high school seniors graduating in 2023, selected from the children and grandchildren of Kimberly Clark Credit Union members.

Students should have a minimum GPA of 3.0 or a "B" average and must enroll at a two-or-four year college or technical school.

Along with the application, the students should submit a transcript, two letters of reference, a photo and an essay on "What I've learned about managing money."

The deadline for submitting an application is **March 31, 2023**.

The scholarship recipients will be notified by May 15th and announced in our July newsletter.
