How to Spot and Avoid Phishing Attempts

Recently, some members have reported receiving emails and text messages appearing to be from Kimberly Clark Credit Union. These messages often warn of an alleged issue with their account, urging immediate action. The communication might include a link, designed to steal sensitive information, or could lead to a request for personal or account details.

Ways to Protect Yourself

Follow these steps to ensure your safety against these "phishing" scams:

- **1. Be Suspicious:** Always question unsolicited requests for your personal or financial information.
- **2. Verify:** If you're unsure whether a message is from KCCU, contact us directly using our official phone r



Stay Vigilant Please remember, KCCU will never ask for sensitive information such as your password, PIN, or Social Security Number via email or text. We use secure methods to communicate sensitive information with our members.

- **3. Look for Signs:** Pay attention to poor grammar, spelling mistakes, or unusual phrasing often associated with phishing attempts.
- **4. Don't Click:** Avoid clicking on links or downloading attachments from unfamiliar sources. These could lead to malicious websites or install malware on your device.
- **5. Update Regularly:** Ensure your device's antivirus software and operating system are always up to date to offer the best defense against phishing and malware.
